#### **19.37 Welcome and membership**

#### 19.41 Flu Clinics

We spoke about Patient Navigators and how useful they had been over the past few months. The Practice would like to ask the group if anybody would be able to help out between 09.00 – 11.00 on Mondays, Wednesdays and Fridays to help first time visitors to the surgery navigate the 2 waiting areas and encourage patients to use the check in screens as often as possible. Anyone interested to let NC know. MK suggested adding colored pictures to the self check in notices we have displayed at reception to catch peoples eye.

SW asked about bus routes to the surgery, SE explained about the transport survey that has been carried out previously and the historic engagement with the bus companies. SE also mentioned the volunteer car scheme, which would benefit our patients and the need for more drivers to join the scheme.

MN suggested the Practice have an Instagram account as well as FB. He will look into this.
